



[MGN Logistics UPS 2021 Rate Increase Review](#)

2020 has been a challenging year for parcel shippers and a year of historical growth for the parcel carriers. Despite this record growth and profitability, UPS announced another 4.9% average general rate increase for 2021. When it comes to carrier increases, it is very important to understand that they affect all shippers differently. The true impact you experience will depend on your business' unique shipment characteristics. Some service levels will see up to almost an 8% increase in rate base adjustments alone!

In addition to the general 4.9% rate increase, UPS has announced that various Accessorial Charges and Value-Added Services will be increasing. For example, this year the minimum charge for UPS Ground Service is going up to \$8.76, or increasing 6.44%. This could translate to an even bigger increase depending on your shipping profile.

Customers that ship larger packages will also feel another impact this year. Effective January 10, 2021, the *Additional Handling Surcharge- Dimensions* will be applied to any package exceeding 105". This is calculated by the combined length plus girth of a package. (length and girth = length + 2x H + 2x W). Effective April 11, 2021, rates for non-Hundredweight Service packages accessed an Additional Handling or Large Package Surcharge will now differ by zone. In July of 2021, this will also apply to Hundredweight Service packages as well.

Also noteworthy to mention is that UPS will be adding hundreds of new zip codes that will now be impacted by Delivery Area Surcharges.

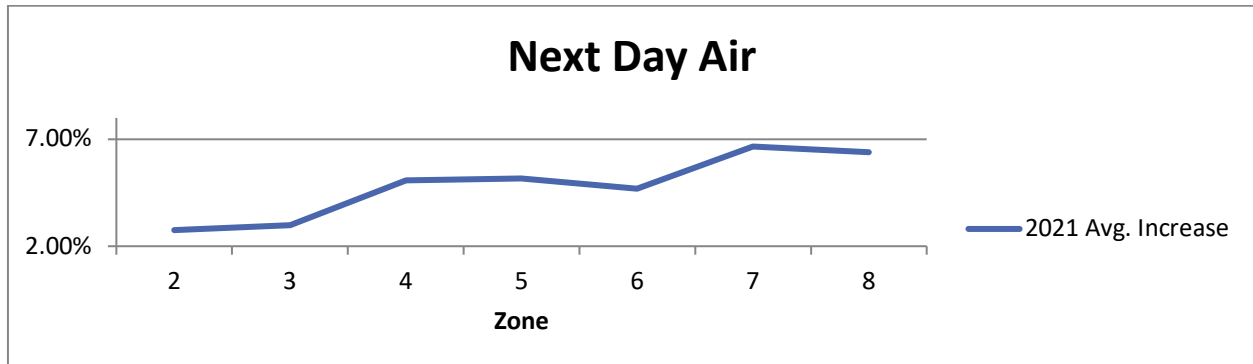

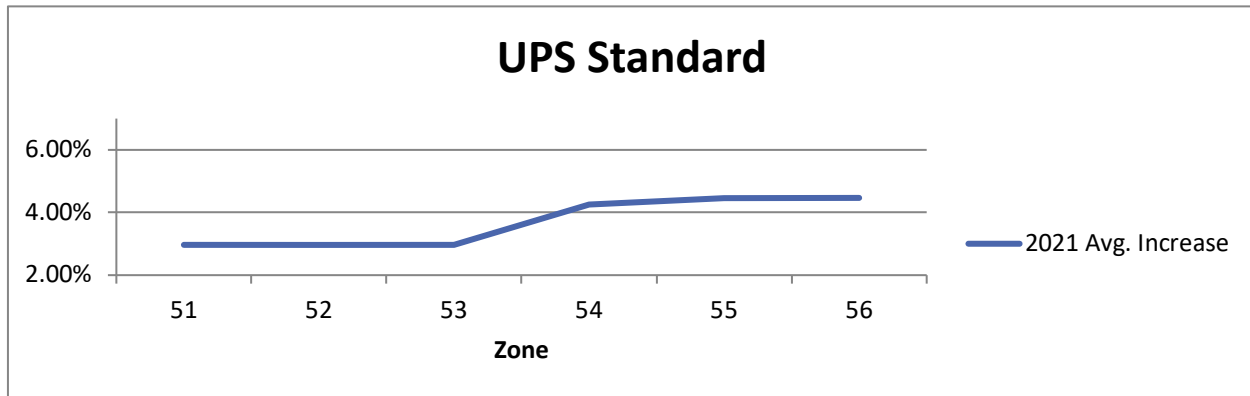
